9. Criteria for admission to the programme

Students admitted to this programme must have:

•An honours degree (2:2 or above) in any discipline.

•Exceptionally, students who do not have a degree but can provide evidence of their ability to study at Masters level may be considered.

•All applicants have the option of going through the RPL (Recognition of Prior Learning) process through Middlesex University, as part of the recruitment and selection process. Students who meet the RPL criteria can carry forward a maximum of 60 credits at level 7 into the MSc.

•Applicants who undertake NSA4760: Advanced Work Based Project should be working in an appropriate environment to be able to complete the project.

•All applicants whose first language is not English are expected to demonstrate their English Language capability at the level required for post-graduate study (IELTS 6.5 or equivalent).

12. Teaching/learning methods

This distance education programme uses a variety of teaching and learning methods, informed by the University Teaching and Learning Strategies which vary according to the type and focus of each module. The Optional skills-based modules are delivered as online live lectures as full teaching days. The teaching and learning methods used include use of pre-recorded lectures, short video clips from expert Professors and researchers, guided reading and linked exercises; online live workshops; online discussion boards; small group work; role play, case studies; problem-based scenarios and practice based learning. Tutorial feedback support via email, phone, Zoom/MS Teams and peer support. Online platforms will be used to enable students to share materials, use online meeting rooms, participate in workshops and video conference.

Students learn cognitive skills through

The use of a variety of teaching and learning strategies, informed by the University and School Teaching and Learning Strategies and which vary according to the type and focus of each module but which may include: seminar preparation and presentation; •use of web-based materials;

•reflective practice and critical evaluation;

•preparation for dissertation/project supervision;

•production of the dissertation or work based project;

range of study skills workshops offered by the course tutors to debate and discuss during
classroom sessions and via on line discussion boards in Unihub and via dissertation supervision sessions and group seminars/workshops

The course also aims to enhance your professional and career development across a range of professional contexts including: mental health, social care, youth justice, prisons and

addictions services and allied professions. You will undertake either a literature-based dissertation (60 credits at level 7) or a work-based project (60 credits at level 7).

Throughout the programme students gain essential graduate competencies in leadership, problem-solving and person-centred professional practice. There are also optional modules where they can develop specialist skills such as Motivational Interviewing or Cognitive Behavioural Therapy.

Students are signposted to the Middlesex employability services (MDXWorks) during their studies. They are also encouraged to join professional organisations such as: International Society of Substance Use Professionals (ISSUP) and International Nurses Society on Addictions, which will enable them to continue their professional development in the field by keeping up to date with research, training and conferences, and network with other professionals.
