•A second class honours classification or above (i.e. 2:2 or above). •GCSE Grade C/4 or above in English or certificated equivalence.

- •Relevant paid or voluntary work experience of at least three months.
- •Applicants whose first language is not English must meet communication and comprehension skills to International English Language Testing System (IELTS) with a score of 7 (with 6.5 in all elements).
- •Successful performance in an individual interview.
- •An assessment of the applicant's suitability and fitness for practice through completion of a self-declaration, appropriate references, a satisfactory check on their criminal record and background including the safeguarding register; Disclosure and Barring Service (DBS) and any further information gathering as indicated via other professionals or further interview and assessment.
- •RPL is not permitted for admission to this programme.

- •Produce post-graduate, qualifying-level social work students who, at the point of completion of their Social Work MA or PGDip, meet all Social Work England Professional Standards and associated Professional Capabilities Framework domains enabling students to apply for professional registration as a social worker with SWE.
- •Develop graduates with leadership capacity able to actively contribute to working in organisations; through offering students an intellectually rewarding and stimulating post-graduate, qualifying-level programme where theory and practice are integrated throughout both academic and practice modules.
- •Equip graduates with an evidence-informed knowledge-base and embed skills for life-long learning.
- •Ensure that graduates are critical, analytical and reflective thinkers and are able to critically evaluate knowledge, to problem-solve, research and develop scholarship through debate and analysis.
- •Promote a collaborative, ethical and transformational approach to working in partnership with the programme's stakeholders, including employers, students, practitioners and people

with lived experience of social work (PWLE); integrating equal opportunities and awareness of diversity at every stage.

- •Provide a coherent and creative curriculum incorporating learning, teaching and assessment strategies that are mapped against Social Work England Professional Standards (2019), linked to the Professional Capabilities Framework and the Benchmark Statement for Social Work (QAA, 2019).

- **7.** Advanced competency in leadership and organisational theory, professional authority and boundary-setting.
- **8.** International/global perspectives on social work and the ability to engage in debates concerning these issues.
- **9.** How to produce an advanced and extended research dissertation exploring a key area of relevance to contemporary social work- [MA level only].

#### 12. Teaching/learning methods

Students gain knowledge and understanding through

- •Large and small group workshops (incl. skills workshops and role plays)
- •Engaging research-based exercises within the classroom and via VLE.
- •Engagement in peer and individual led classroom presentations which demonstrate synthesis and interrogation of different sources of knowledge, which promote co-leadership.
- •Assessed professional practice learning practice tutorials in placement.
- •Accommodation to students' individual learning needs provided within the classroom and in practice placement setting to promote inclusive learning.
- •Guidance provided in class and on VLE on how to plan individual study and on assessment preparation, including pre- and post- classroom delivery exercises.
- •Debate and discussion in small and large groups and through reading and critical reflection on learning materials, with a focus on evidence-informed practice, and to enhance UN Sustainable Development Goals.

Students learn skills through:

- •Reflective activities, such as reflective diaries, experiential exercises and group discussion.
- •Communication skills and theory/intervention workshops.
- •Interrogating and debating learning materials, individually, in seminar settings and on-line.
- •Recording and evaluating student's own overall development and progress through the

programme via the placement planning documents which enhance practice learning and employability.

#### 13b Employability development

Development of graduate competencies

MA and PGDip Social Work are professional education programmes, with successful completion resulting in eligibility for graduates to apply to the regulator, Social Work England, for registration. Therefore, development of professional graduate competencies run throughout every element of the programme.

Students undertake 170 days of assessed professional practice learning in employer partner settings, concurrently to classroom-based learning. On placements, students gain first hand work experience, in an incremental and planned way, appropriate to the stage of their studies. Placements are carefully quality assessed and students are supported and guided by Practice Educators, who are experienced, qualified social workers and educators, along with university tutors. In addition, 30 days practice skills are delivered by the course team, people with lived experience of social work and practice partners, to enhance professional practice learning and employability. Sessions on applying successfully for jobs, interview skills and information on Assessed and Supported Year of Employment (ASYE) are run with students on the programme. Through these experiences, students gain essential graduate competencies in leadership, problem-solving and person-centered professional practice. Every aspect of the curriculum is mapped to SWE Education and Training Standards and Professional Standards to retain approved status. This is confirmed through SWE Annual Monitoring processes.

#### **Employability Development**

MA and PGDip Social Work programmes are qualifying professional programmes and new graduates can apply direct to Social Work England for registration. Employability is therefore integrated into the programmes from beginning to end. During induction, new students are introduced to employer partners, who explain local authority, private and voluntary agency roles, and employer expectations of, and opportunities for, graduates. Programme partnerships are strong with local authority providers, private and voluntary agencies. Students attend two practice placements with partner social care agencies during their studies and are prepared and assessed on their professional skills and knowledge throughout the programmes, preparing them for employment in a very direct way. Students have structured sessions with Middlesex

employability services (MDXWorks) during their studies, to ensure they are work-ready via job application and role play interview preparation, with employer partners taking part. We invite alumni to speak to current students during their studies, to encourage and inspire.

#### 13c Placement and work experience opportunities (if applicable)

With MA and PGDip Social Work, compulsory practice learning takes place in organisations and settings centered on the provision of social work and social care. A total of 170 days assessed practice placement learning must be achieved to be eligible for registration with SWE. Our placements are all quality-assured and the learning opportunities are identified in accordance with the thresholds of learning in the Professional Capabilities Framework (BASW 2018) and SWE Education and Training Standards (2021). For example, students can expect to typically have their first placement in a community-based setting within the private, voluntary or statutory sector where they will gain experience of direct work with service users and carers, in undertaking assessments and interventions and of working with other professionals within inter-professional networks. In the final placement students will gain experience of undertaking statutory tasks and are likely to be placed in a local authority or health trust providing adult or children's services. Placements are matched to students' learning needs. Students are taught on placement, by qualified Practice Educators and are supported by university tutors.

#### 13d Future careers / progression

There are a wide variety of career opportunities for qualified social workers in the statutory, voluntary and independent sectors. These are with different user groups in different models of social welfare.

The University organises annual career fairs for students. On MA and PGDip Social Work programmes, tutors support students' preparation through their Tutor Groups and professional development planning as well as linking them to the central university services. Employability workshops are offered to students, by MDXworks, staff and employers, drawing on the excellent partnerships in place between the university and employers.

#### 14. Assessment methods

Assessment methods

Students' knowledge and understanding is assessed by:

Research-based exercises in practitioner enquiry [culminating in the writing of a dissertation-MA level only].

Peer and individual presentations which demonstrate synthesis and interrogation of different sources of knowledge, employed during research and practice- related teaching and learning

Focused debate and discussion in small and large groups

Practice learning portfolios connecting knowledge (formal & informal) and placement practice skills

Presentation, discussion and analysis of case studies

Online searches and critiques of findings.

Students' skills are assessed by:

Tutorial-based exercises through debates, discussion and communication /intervention assessment activities.

Research evaluation activities and drawing out implications for practice [including the production of a dissertation- MA level only].

Written assignments and presentations demonstrating critical understanding of theories and knowledge and their application.

#### <u>Year 1</u>

To graduate with a social work qualifying award all modules must be passed. Students enrolled on MA Social Work may however exit with PGDip Social Work (qualifying), if they pass all modules apart from SWK4720 dissertation module. All modules are core apart from SWK4720 Dissertation.

Students must pass their readiness for direct practice interview and assignment from SWK4800 RDP module before progressing to their first placement (SWK4710). Students must pass SWK4710 before progressing to SWK4711 Final placement module Students must pass SWK4900 before progressing to SWK4711 Final placement module

#### 16. Programme-specific support for learning

When studying on MA and PGDip Social Work programmes, students have an allocated personal tutor (Academic Advisor) throughout the programme, who oversees the academic and professional development of students. While on placement, they will have a Practice Educator who will deliver their practice learning and assessment in the workplace in a supportive manner.

We recognise that students on the postgraduate qualifying programmes may be returning to study after period, so support is integrated into the curriculum, by effective use of the University Student Support Services and the Information and Learning Resource Services.

Additional information for MA and PGDip Social Work programmes:

Owing to the professional nature of these programmes, there are several additional regulations. The University is required to abide by the entry threshold criteria set by the Professional Capabilities Framework (BASW 2018) and Social Work England Education and Training Standards (2021). In addition, students must pass the SWK4800 readiness for direct practice assessment in term one before they can commence their first 70-day placement. Prior to commencement of the final 100-day placement students must also have passed the Social Work Law module SWK4900. Fitness for Practice is assessed continuously throughout and complies with the University Fitness for Practice Framework. Breach of these procedures may lead to an investigation and subsequently the student may be asked to leave the programme.

All components of the programme must be successfully completed before MA or PGDip Social Work can be awarded. Fail grades are not compensated for on any social work module.

A minimum of 75% student attendance is required for all MA and PGDip Social Work academic modules for students to be entered for assessment. Professional regulatory requirements are that students must complete the full 70 days of the first placement and 100 days in the second. Students must also complete 30 days of direct practice skills throughout their programme.

In line with the University Regulations regarding the assignments, students have two attempts for the modules' summative assessments.

Placements are the exception to this where a second attempt at placement is only given following an independent investigation into the circumstances by a member of the academic team, with the recommendation for the second attempt endorsed by the external examiner.

In some exceptional circumstances student who double failed a module may be considered to retake the module again entirely with a fee in following academic year at Programme Lead and Director of Programmes discretion. In this case it may impact on a student's progression on the Programme as practice placements cannot be taken while the fail is outstanding.
